3. DISCUSSION: KLFR&EMS Proposed FY 2020-2021 Budget

Jennifer Johnson discussed the changes to the Proposed FY 2020-2021Budget:

The changes include:

DISTRICT

Acct 110 (Board Member Stipends): This item increased by \$9,000. If the Resolution is approved, the Board Member Stipends would increase from \$200 per month to \$350 per month.

FIRE DEPARTMENT

<u>Acct 120: (Regular Salaries & Wages):</u> This account now includes two additional Holidays (Easter and Veterans Day). The Driver Certification incentive pay was increased from 2% to 4%. Both of these increases are to help encourage retention.

<u>Acct 230 (Employee Insurance Benefits):</u> The full-time firefighter's insurance benefit was raised to \$575.00 per month to encourage retention.

<u>Acct 640 (Capital Outlay – Equipment):</u> This account was increased by \$14,995 to purchase a Structural Collapse Camera.
