1. AGENDA

1a. Call to Order

Chairman Allen called the Zoom video conference of the Final Public Hearing to order at 6:01 p.m.

The Fire Department is obtaining quotes, and has received two quotes, and expect one additional quote for the Station 24 Door Replacement. It appears the cost will be approximately \$10,000.

4. DISCUSSION: KLFR&EMS Proposed FY 2020-2021 Budget

Jennifer Johnson discussed the Proposed FY 2020-2021 Budget, and there were no changes from the budget presented at the $1^{\rm st}$ Public Hearing. The proposed millage is 1.0000 mills with a rolled-back rate of 0.9588 mills by 4.30%

The Corps requested a Step-Plan. The cost would be approximately \$3,000. The Corps felt this addition did not require a change to the budget; however, if necessary, the Corps might submit a Budget-Line Transfer.

The proposed revenues are \$7,234,705. The total expenditures and transfers are projected at \$4,147,887. The District is expected to end the year with an unassigned fund balance of \$2,725,748, a committed Trauma District fund balance of \$6,226, and a committed vehicle replacement fund balance of \$580,114 for total expenditures and fund balances of \$7,234.705. The total proposed FY 2020-2021 budget is \$7,234,705.
